Europarc

Europarc is the flagship Business Park of North East Lincolnshire. It is home to some of the Region's leading food businesses, with over 2000 employed on site. Major employers include Morrisons, Cofely, Daniels, Albert Darnell, Two Sisters Food Group and the Humber Seafood Institute. The Business Park has over 725,000 sqft of business space already developed and has been designed to attract manufacturing, distribution and office based businesses at all stages of their development in high quality, cost-effective, purpose-built accommodation within attractive landscape grounds.

Several amenities are available on the estate including three food outlets following the recent completion of the Farmhouse Inn and Restaurant and in future will include hotel, children's nursery and other retail/leisure offerings. A sustainable transport strategy is also in operation providing bus routes and cycle paths to Grimsby Town Centre and surrounding areas.

With a population of 160,000 North East Lincolnshire is an integral part of the Humber Region, which has the busiest port network in the UK, and major business links to Mainland Europe.

















Development

Wykeland has an impressive 45-year record in designing, developing and delivering over 10.5M sqft of commercial development in a variety of sectors and locations throughout England and Scotland. Outline planning consent has been obtained at Europarc with the potential to deliver a development pipeline for a further 600,000 sq ft of business space and 1700 FTE jobs.





Detailed planning consent has been obtained for a 126,000 sq ft food manufacturing facility on a prominent 7 acre site at the entrance to Europarc. The development is capable of being delivered in a 11 month construction programme with early access for fit-out available.
